2023 Cloud Native M&A Review

In 2023 Cloud Native M&A continued to slow with 14 deals, compared to 18 in 2022 and 33 in 2021. Public buyers returned in 2023 accounting for 6 of the 14 deals or 43% with the remaining 8 deals by 7 VC-backed companies and 1 PE firm. Comparatively, in 2022 3 of the 18 deals were by public companies.

Security continued to have the most deals in 2023 with 6 or 43% of the total. In 2022 Snyk was a leading acquirer and continued on that path in 2023 with 2 Security/Networking acquisitions and was joined by Cisco which acquired 2 Security/Networking companies as well. Harness was another leader with 2 DevOps/CI/CD acquisitions.



2023 Cloud Native Venture Funding

Cloud native venture funding totaled \$459M across 23 rounds with an average round size of \$20.8M. This is down significantly from the \$1.6B raised in 2022 across 26 rounds with an average round size of \$59.7M. The good news is that 2023 was a year of funding new startups. The number of 1st rounds accounted for 52% or 12 of the 23 and \$131M or 28.6% of total funding.

In 2023 Management/Orchestration was the most funded segment at \$184M across 12 rounds with an average round size of \$17.3M. It includes the 3^{rd} and 4^{th} largest rounds of the year with Cast Al's \$25.0M 2^{nd} round and CloudZero's \$32.0M 2nd round. Monitoring/Logging was the second most funded segment at \$181M across 3 rounds with an average round size of \$60.3M. It includes the 2 largest rounds of the year with Chronosphere's \$115M 3^{rd} round and Honeycomb's \$50.0M 4^{th} round.



The Top Five rounds in 2023 totaled \$257M or 56% of total funding. Chronosphere, a cloud native observability platform, raised the largest round at \$115M, which came on the heels of a record revenue year.
